



# Rental Terms & Conditions Steekflens B.V. en Flangebreaker B.V.

### Article 1: Description

These Rental Terms & Condition are an <u>addition</u> on the by Steekflens B.V. and Flangebreaker B.V. used metaalunievoorwaarden. Together they are called "The Terms" and are they, by placing a purchase order, accepted and an integrated part of all (rental) agreements.

### Article 2: Validity

The terms are valid on all quotations, agreements made by or with Steekflens B.V. and or Flangebreaker B.V. no matter the kind of agreement.

# Article 3: Rental period

- 3.1 Rent price is price per working-week. Minimal rental period is 1 week. 2 days in the new week is 1/2 a week. Longer is 1 new week.
- 3.2 Rental period starts on the time and date as agreed in writing, more specific:
- A. If agreed to pick up the goods at a certain location on the moment the goods are handed over by Steekflens B.V. or Flangebreaker B.V.
- B. If agreed that goods are delivered by Steekflens B.V. of Flangebreaker B.V. the moment the goods are delivered on site.
- C. Unless otherwise agreed and confirmed in writing the given rental period is an indication, subject to above mentioned.

### Rental period ends:

- 3.3 Rental period ends on the time and date as agreed in writing, more specific:
- A. i If agreed to return the goods to a certain location on the moment the goods are handed over to Steekflens B.V. or Flangebreaker B.V.
- B If agreed that goods are picked up by Steekflens B.V. of Flangebreaker B.V. the moment the goods are picked up on site.
- 3.4 Transports to and from an Steekflens B.V. or Flangebreaker B.V. warehouse are excluded from rental fee and will either be taken care of by customer or charged as extra if supplied by Steekflens. B.V.





## Article 4. Damaged or missing goods

### 4.1 Rental of Blindspade products

With this all goods on the website of <a href="www.blindspades.com">www.blindspades.com</a> are mentioned. If damaged or missing these goods will be charged at 70% of the website prices with no compensation for the, actual, rental period.

### 4.2 Rental of Flangebreaker products.

At start of the agreement the replacement value will be mentioned in writing. When damaged or missing, good will be charged as per this mentioned value with no compensation for the, actual, rental period.

#### Article 5. Return clause

- 5.1. Rent-customer guarantees that returned goods are free of any (product) contamination or gasket remains.
- 5.2 Specific for Flangebreaker products soft gaskets are removed before cleaning and ARE NOT returned to Flangebreaker BV.
- 5.3 Steekflens B.V. or Flangebreaker B.V. has the right to refuse contaminated products or product with SUSPISION of contamination. In this case Customer than has 3 days to correct / clean the goods and to return in the proper way. If not, goods will be treated as damaged or missing as mentioned in Article 4.
